8 order that their name(s) be deleted from the membership roll.

9 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the  
10 08TH day of FEBRUARY, 1999 at a meeting at which a quorum was present with a vote of  
11 1,846.5 FOR; 80.5 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers  
12 vested in the Council by Article II, Section 3 and Article IV, Section 1(h) of the Constitution  
13 of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,  
14 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations)  
15 on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
