

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(In Support of the Venito Garcia Library State of Arizona Department of Library,**  
**Archives and Public Records SFY-1999 Grant Award)**

**RESOLUTION NO. 99-043**

1 WHEREAS, the Tohono O'odham Legislative Council is charged with the  
2 responsibility of supporting and promoting educational programs for all  
3 Tohono O'odham; and

4 WHEREAS, the Tohono O'odham Education Department/Venito Garcia Library was  
5 awarded \$20,000.00 from State funding with matching funds in the  
6 amount of \$20,000.00 from the Tohono O'odham Nation; and

7 WHEREAS, the State's funding contribution will be utilized specifically for purchase  
8 of capital equipment and building alterations and renovations.

9 NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative  
10 Council fully supports the Venito Garcia Library's State of Arizona  
11 Department of Library, Archives and Public Records SFY-1999 grant  
12 award in the amount of \$20,000.00.

13 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council, Tohono  
14 O'odham Nation's Officials, to wit: the Chairman and any designated  
15 official are hereby authorized to execute the grant award, provided  
16 however that any amendments affecting the funding or funding levels of  
17 this grant shall be submitted for further approval.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH day  
19 of FEBRUARY, 1999 at a meeting at which a quorum was present with a vote of 1,927.0  
20 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers  
21 vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono  
22 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
23 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
24 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


