

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(TODHS-Division of Child Welfare Services-FY99/2000 Family
Preservation/Support Services, Title IV-B Subpart 1, G-9901-AZ-1506
Modification #1; Acct. No. 11-1318)**

RESOLUTION NO. 99-044

1 WHEREAS, the Tohono O'odham Nation is presently operating the FY 1998 Grant
2 with the Title IV-B, Subpart 1 of the Social Security Act - five (5) year
3 plan; and

4 WHEREAS, any modifications affecting the funding and funding levels of the grant
5 shall be submitted for review and approval by the Tohono O'odham
6 Legislative Council; and

7 WHEREAS, the Title IV-B, Subpart 1 of the Social Security Act has decreased the
8 allocation from \$50,652.00 to \$45,582 to cover the FY99 budget that covers
9 a two year period (October 1, 1998 - September 30, 2000); and

10 WHEREAS, an attached modification has been submitted for review and approval by
11 the Tohono O'odham Department of Human Services - Division of Child
12 Welfare Services/Family Preservation Program.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
14 that:

15 1. The Tohono O'odham Legislative Council authorizes expenditures of
16 these funds according to the attached budget for the following program:

17 A. Family Preservation and Support Services

18 2. That the Tohono O'odham Nation, to wit, the Chairman and any
19 designated Official are hereby authorized to negotiate and execute the
20 grant.

21 The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH day
22 of FEBRUARY, 1999 at a meeting at which a quorum was present with a vote of 1,927.0
