2 **Health Services and Community Health Representatives under FY 1999**
3 **P.L. 93-638 Master Health Contract No. 249-96-0001 with the Indian Health**
4 **Services; and**

5 **WHEREAS, a budget modification is submitted for review and approval by the**
6 **Department of Human Services Community Health Services/Community**
7 **Health Representative Divisions to eliminate a Home Health Aide vacant**
8 **position to cover leasing additional vehicles and line items pertaining to**
9 **vehicles; and**

10 **WHEREAS, an amendment has been submitted for review and approval by the**
11 **Department of Human Services, Divisions of Community Health**
12 **Services/Community Health Representatives.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**
14 **that:**

- 15 **1. It hereby approves the amendment and authorizes expenditures in**
16 **accordance with the attached budget modification #1 submitted by**
17 **the Community Health Services/Community Health Representatives.**
18 **2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice**
19 **Chairman and any designated Official are hereby authorized to**
20 **negotiate and execute this contract and to expend funds when**


1 The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH day
