**RESOLUTION NO. 99-048**

1   **WHEREAS, there are no other attorneys to handle conflicts which the Nation's**  
2                   **Advocate Program is not ethically allowed to handle in the increasing**  
3                   **needs of tribal members for legal representation in civil and criminal**  
4                   **matters; and**

5   **WHEREAS, the Advocate Program wishes to retain Margo Donaldson as a Conflict**  
6                   **Attorney to be appointed to represent clients with conflicts of interest**  
7                   **who can not be represented by the Nation's Advocate Program; and**

8   **WHEREAS, the Advocate Program wishes to retain Margo Donaldson as a Conflict**  
9                   **Attorney for the twelve (12) months of FY-99, and projects the cost of such**  
10                  **services at \$20,000.00; and**

11   **WHEREAS, the Advocate Program has presented a contract for Margo Donaldson**  
12                  **which confirms and ratifies the terms and conditions related to future**  
13                  **services, a copy of which is attached; and**

14   **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative**  
15                  **Council of an Attorney Contract with Margo Donaldson on such terms.**

16   **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 17                   **1. The Legislative Council ratifies and approves the Conflict Attorney**  
18                   **Contract for Margo Donaldson in the form attached hereto, for the**  
19                   **period of October 1, 1998 through September 30, 1999 in the amount**  
20                   **not to exceed \$20,000.00 total.**
- 21                   **2. Funding for the Conflict Attorney Contract for Margo Donaldson**




