

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Re-Appropriation of the Executive Branch Fiscal Year 1998 Capital and
Facility Funds for Fiscal Year 1999; Authorization of Expenditure)**

RESOLUTION NO. 99-049

1 WHEREAS, for fiscal year 1998 the Executive Branch were appropriated capital and
2 facility funds to address various needs of the Nation's programs and
3 departments; and

4 WHEREAS, the Executive Office of the Chairman has identified certain capital and
5 facility projects which require additional authorization to permit the
6 completion of approved projects during fiscal year 1999 and requests that
7 the associated funds for these projects be re-authorized and re-
8 appropriated; and

9 WHEREAS, the funds appropriated in fiscal year 1998 have not been re-obligated and
10 remain restricted, available only for the projects for which the funds were
11 intended for.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
13 that the attached budget, *Fiscal Year 1999 Proposed Carry Forward of*
14 *Fiscal Year 1998 Capital and Facility Appropriations*, is hereby approved
15 as submitted and is authorized to be expended accordingly.

16 BE IT FURTHER RESOLVED that the balances as identified by the attached budget
17 are hereby re-appropriated and re-authorized.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 09TH day
19 of FEBRUARY, 1999 at a meeting at which a quorum was present with a vote of 1,927.0
20 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers
21 vested in the Council by Section 1(d) (2) & (3) of Article VI of the Constitution of the
22 Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986;
23 and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations)
24 on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
