**RESOLUTION NO. 99-050**

- 1   **WHEREAS, the Legislative Council of the Tohono O'odham Nation approved the**  
2           **formation and organization of the Economic Development Department,**  
3           **and authorized its FY 1998 budget by means of Resolution 98-064; and**
- 4   **WHEREAS, the Executive Branch of the Tohono O'odham Nation ordered the**  
5           **Economic Development Task Force and the Economic Development**  
6           **Department to assume additional new duties with respect to Economic**  
7           **Development by means of Executive Order 98-02; and**
- 8   **WHEREAS, Executive Order 98-02 authorizes the Economic Development Task Force**  
9           **to develop budgets and undertake administrative tasks needed to**  
10          **implement the Order; and**
- 11   **WHEREAS, the Economic Development Task Force developed the attached budget**  
12          **and organizational proposals to implement Executive Order 98-02; and**
- 13   **WHEREAS, the Executive Office of the Tohono O'odham Nation has reviewed the**  
14          **proposals; it agrees with the proposed organization and budget; and it**  
15          **authorized the Economic Development Task Force to seek approval and**  
16          **authorization by action of the Legislative Council; and**
- 17   **WHEREAS, the Commerce Committee and the Budget and Finance Committee of the**  
18          **Legislative Council have reviewed these proposals and recommended**  
19          **approval; and**
- 20   **WHEREAS, Legislative Council appropriated funds as Administrative Costs for the**  
21          **Implementation of the Initiative by means of Resolution 97-451; and**
- 22   **WHEREAS, sufficient funds remain unencumbered from this appropriation to fund**

2 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono  
3 O'odham Nation that the Economic Development Department of the  
4 Executive Branch is authorized to expend funds pursuant to the attached  
5 budget from the set aside created by the Legislative Council as  
6 Administrative Costs for Implementation of the Initiative.

7 BE IT FURTHER RESOLVED that the Chairman of the Tohono O'odham Nation is  
8 authorized to negotiate and enter into contracts or Intergovernmental  
9 Agreements for goods and services specified in this budget.

10 The foregoing Resolution was passed by the Tohono O'odham Council on the 09TH day  
11 of FEBRUARY, 1999 at a meeting at which a quorum was present with a vote of 1,927.0  
12 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers  
13 vested in the Council by Section 1(d) & (f) of Article VI of the Constitution of the  
14 Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986;  
15 and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations)  
16 on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


