

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Initiative Legal Research Budget and Amendment No. 1 to
Attorney Contract with the Law Firm of Raven & Kirschner)**

RESOLUTION NO. 99-058

- 1 **WHEREAS, by Resolution 97-518, the Legislative Council approved a budget in the**
2 **amount of \$50,000 for fiscal year 1998 (Account No. 1-1809(810) for legal**
3 **costs related to the implementation of the Initiative (the "Legal Research**
4 **Budget"); and**
- 5 **WHEREAS, a Legal Research Budget in the amount of \$50,000 for fiscal year 1999 has**
6 **not yet been approved; and**
- 7 **WHEREAS, pending approval of the Budget for fiscal year 1999, by Resolution 98-404**
8 **the Legislative Council authorized continuing expenditures at the rate**
9 **approved in the fiscal year 1998 Budget for the period ended December**
10 **31, 1998; and**
- 11 **WHEREAS, by Resolution 98-468, the Legislative Council approved an Attorney**
12 **Contract with the law firm of Raven & Kirschner (the "Attorneys") in the**
13 **amount of \$12,500 for the fiscal period ended December 31, 1998; and**
- 14 **WHEREAS, the purpose of the Attorney Contract is to provide assistance to the Office**
15 **of Attorney General in assessing the tax implications for the Nation and**
16 **its members associated with the implementation of the Initiative; and**
- 17 **WHEREAS, continued representation is necessary to protect the Nation's interests in**
18 **these matters; and**
- 19 **WHEREAS, the Domestic Affairs Committee recommends approval of the Legal**
20 **Research Budget and Amendment No. 1 to the Attorney Contract for fiscal**
21 **year 1999.**

1 NOW, THEREFORE, BE IT RESOLVED THAT:

- 2 1. The Tohono O'odham Legislative Council approves the Initiative
3 Legal Research Budget in the amount of \$50,000 for fiscal year 1999,
4 in the form attached hereto.
- 5 2. The Legislative Council approves Amendment No. 1 to the Attorney
6 Contract with the law firm of Raven & Kirschner, in the form
7 attached hereto, which increases the Contract amount from \$12,500 to
8 \$20,000 and extends its term through September 30, 1999.
- 9 3. The Legislative Council authorized expenditure of the Contract
10 amount from Account No. 1-1809(810).
- 11 4. The Chairman is authorized and directed to execute Amendment No.
12 1 to the Attorney Contract.

14 The foregoing Resolution was passed by the Tohono O'odham Council on the 09TH day
15 of FEBRUARY, 1999 at a meeting at which a quorum was present with a vote of 1,254.0 FOR;
16 673.0 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the
17 Council by Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation,
18 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
19 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
20 Section 16 of the Act of June 18, 1934 (48 Stat. 984).


