8	WHEREAS,	by Resolution No. 96-387, the Legislative Council suspended the Restated
9		Plan of Operation for the Tohono O'odham Farming Authority for 180
10		days and authorized the Chairman to : (i) secure and take control of any
11		and all assets of the Farming Authority; (ii) conduct a fraud audit; and (iii)
12		initiate any and all necessary steps to insure that the day-to-day farming
13		operations continue without interruption during the suspension; and
14	WHEREAS,	by subsequent Resolutions of the Legislative Council, the Chairman's
15		authority under Resolution No. 96-387 has been extended beyond the
16		initial 180 day period; and
17	WHEREAS,	the Chairman of the Nation and his appointed Executive Agriculture
18		Committee have introduced reforms to the Nation's farming operations
19		in furtherance of the direction of the Legislative Council in Resolution
20		No. 96-387; and

WHEREAS, the Chairman of the Nation and appointed Executive Agriculture Committee recommend the approval and adoption of the Second Restated Plan of Operation in the form attached hereto.
