

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Appointing Rosemary Lopez to the Tohono O'odham Farming Authority**  
**Management Board)**

**RESOLUTION NO. 99-065**

1 WHEREAS, the Second Restated Plan of Operation for the Tohono O'odham Farming  
2 Authority calls for the appointment of the Directors of the Farming  
3 Authority Management Board by the Chairman of the Tohono O'odham  
4 Nation, with the approval of the Legislative Council; and

5 WHEREAS, Rosemary Lopez of Chukut Kuk District has been nominated to serve as  
6 a Director representing Chukut Kuk District; and

7 WHEREAS, the Chairman of the Nation has appointed Ms. Lopez to serve as a  
8 Director representing Chukut Kuk District for an initial term of three  
9 years in accordance with Sections 4.1.1 and 4.3.1. of the Second Restated  
10 Plan of Operation for the Tohono O'odham Farming Authority; and

11 WHEREAS, Ms. Lopez agrees to serve as a Director for that term.

12 NOW, THEREFORE, BE IT RESOLVED THAT the Legislative Council approves the  
13 appointment of Rosemary Lopez to serve as a Director on the  
14 Management Board of the Tohono O'odham Farming Authority as the  
15 Chukut Kuk District Representative for an initial term of three years  
16 which term shall end on August 31, 2002.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 10TH day  
19 of FEBRUARY, 1999 at a meeting at which a quorum was present with a vote of 1,481.0  
20 FOR; 446.0 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers  
21 vested in the Council by Section 1(b) of Article VI of the Constitution of the Tohono  
22 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
23 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
24 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




