

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Approval of Addendum No. 2 to the Professional Services Contract between  
Korn, Waterman and Simon and the Tohono O'odham Nation)

**RESOLUTION NO. 99-067**

1 WHEREAS, the Tohono O'odham Nation entered into a Professional Services Contract  
2 with Korn, Waterman and Simon for Attorney Services to the Legislative  
3 Council with a total contract amount of \$25,000 per Tohono O'odham  
4 Legislative Council Resolution No. 98-400; and

5 WHEREAS, additional funds are needed in addition to the original contract amount;  
6 and

7 WHEREAS, the officers of the Legislative Council recommend that the contract  
8 amount be increased by \$15,000.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council  
10 approves Addendum No. 2 to the Professional Services Contract between  
11 Korn, Waterman and Simon and the Tohono O'odham Nation in the form  
12 attached hereto, providing an increase of \$15,000 in the contract amount  
13 for a total contract amount of \$40,000 to be paid from Account No. 01-  
14 1002-810 and authorizes the Chairman of the Nation and the Chairman of  
15 the Legislative Council to sign the Addendum.

16 The foregoing Resolution was passed by the Tohono O'odham Council on the 10TH day  
17 of FEBRUARY, 1999 at a meeting at which a quorum was present with a vote of 1,226.0 FOR;  
18 512.0 AGAINST; -0- NOT VOTING; and 189.0 [04] ABSENT, pursuant to the powers vested  
19 in the Council by Section 1 (d)(3) & 2(a) of Article VI of the Constitution of the Tohono  
20 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
21 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March  
22 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


