

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization to Reappropriate funds for Purchase of Fire Equipment)**

RESOLUTION NO. 99-068

1 **WHEREAS, the acquisition of additional equipment is necessary to provide adequate**
2 **fire protection services to the members of the Tohono O'odham Nation;**
3 **and**

4 **WHEREAS, by Resolution No. 97-038, the Legislative Council authorized the**
5 **Chairman of the Nation, the Chairpersons of the Commerce and Budget**
6 **& Finance Committees, the Attorney General, and the Chief of the Fire**
7 **Department to negotiate contracts to acquire the fire trucks; and**

8 **WHEREAS, on the date of February 13, 1998 contracts were signed for the purchase of**
9 **one (1) Pierce Quantum Custom Pumper/Tanker and three (3) Pierce**
10 **Saber Custom Pumper; and**

11 **WHEREAS, each truck was to be custom made and would take eight (8) months to**
12 **deliver; and**

13 **WHEREAS, remaining monies were to be utilized to purchase all capital equipment**
14 **needed; and**

15 **WHEREAS, the capital equipment purchase was delayed pending delivery of the**
16 **custom made trucks to assure proper equipment was ordered; and**

17 **WHEREAS, the Fire Department request to reappropriate remaining monies in the**
18 **amount of \$176,487.00 to purchase fire capital equipment that will be**
19 **essential to the operation of these new fire trucks.**

20 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 21 **1. The Tohono O'odham Legislative Council hereby authorizes carry**
22 **over funding from Fiscal Year 1998 to Fiscal Year 1999 and authorizes**
23 **Capital purchases in the amount of \$176,487.00 for the acquisition of**
24 **the fire equipment.**

6 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March
7 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


