

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY-99 Vi-ikam Doag Industries, Inc., Administrative and**  
**Interim Business Budget)**

**RESOLUTION NO. 99-070**

1 WHEREAS, at the Legislative Council regular session on February 10, 1999, the Vi-  
2 ikam Doag Industries Board member(s) did present the Vi-ikam Doag  
3 Industries FY-99 Administrative and Interim Budget; and

4 WHEREAS, the Tohono O'odham Legislative Council did review the proposed budget  
5 of the Vi-ikam Doag Industries; and

6 WHEREAS, the Tohono O'odham Legislative Council did determine that the VDI  
7 budget request is consistent with P.L. 99-503; and


8 WHEREAS, the San Lucy District Council (Res. # SL 12-91-98) did approve the VDI  
9 FY-99 Administrative and Interim Business budget.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council  
11 does approve the FY-99 Administrative and Interim budget of the Vi-ikam  
12 Doag Industries Inc. in the amount of \$765,505.00.

13 BE IT FURTHER RESOLVED that the amount of \$765,505 be transferred to VDI's  
14 Account from the P.L. 99-503 Investment Account at the earliest possible  
15 time.

16 The foregoing Resolution was passed by the Tohono O'odham Council on the 10TH day  
17 of FEBRUARY, 1999 at a meeting at which a quorum was present with a vote of 1,738.0  
18 FOR; 0 AGAINST; 0 NOT VOTING; and 189.0 [04] ABSENT, pursuant to the powers  
19 vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono  
20 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
21 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
22 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


