RESOLUTION NO. 99-076

1 **WHEREAS, supplement monies in the amount of \$5.5 million was requested by the**
2 **District Chairpersons from the Tohono O'odham Nation's savings**
3 **account; and**

4 **WHEREAS, by Resolution No. 98-486 of the Tohono O'odham Legislative Council**
5 **requested supplement funding that was approved to be equally**
6 **distributed among the eleven districts; and**

7 **WHEREAS, the Gu Achi District Council on February 11, 1999 approved the**
8 **supplement budget in the amount of \$500,000.00; and**

9 **WHEREAS, the Gu Achi District Council hereby submits its supplement budget**
10 **approved on February 11, 1999 in the amount of \$500,000.00; and**

11 **WHEREAS, gaming revenue supplement monies for Gu Achi District will be**
12 **deposited in an account with Bank of America, Tohono O'odham Branch**
13 **8091 in Sells, Arizona; and**

14 **WHEREAS, any budget modification throughout FY-99 is at the discretion of the Gu**
15 **Achi District Council; and**

16 **WHEREAS, any amendments to the FY-99 supplement budget involving new line**
17 **items shall be approved by the Tohono O'odham Legislative Council.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative**
19 **Council has reviewed the Gu Achi District Council supplement budget**
20 **and approves the same.**

21 **BE IT FURTHER RESOLVED that the expenditure period for these funds is January 01,**
22 **1999 through December 01, 1999.**

7 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


