1 WHEREAS, the Tohono O'odham Nation is presently, operating the Low Income
2 Home Energy Assistance Program operating through a contract with the
3 State of Arizona, Department of Commerce; and

4 WHEREAS, any amendments affecting the funding levels of the grant shall be
5 submitted for review and approval by the Tohono O'odham Legislative
6 Council; and

7 WHEREAS, the Tohono O'odham Department of Human Services has submitted for
8 review and approval, budget modification no. 1 submitted by the Low
9 Income Home Energy Assistance Program..

10 NOW, THEREFORE, BE IT RESOLVED:

- 11 1. That the Tohono O'odham Legislative Council does hereby approve
12 budget modification no. 1 submitted by the Low Income Home Energy
13 Assistance and authorizes expenditures in accordance to the attached
14 budget modification no. 1.
- 15 2. That the Tohono O'odham Nation Officials to wit: the Chairman and
16 Vice Chairman and any designated official are hereby authorized to
17 negotiate and execute the contract.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 02ND.
19 day of MARCH, 1999 at a meeting at which a quorum was present with a vote of 1,927.0
20 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers
21 vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono
22 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
23 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
24 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


