RESOLUTION NO. 99-088

1 WHEREAS, the Tohono O'odham Nation Department of Human Services is presently
2 operating the Division of Alcoholism and Substance Abuse Program
3 Component under P.L. 93-638 Master Health Contract with the Public
4 Health, Indian Health Services; and

5 WHEREAS, the Grants and Contracts Office has notified the DASA-Rehabilitation
6 Aftercare Program of carry over funds available for obligation under FY
7 98 Master Health contract; and

8 WHEREAS, a budget modification has been prepared for review and approval by the
9 DASA-Rehabilitation Aftercare Program to utilize the contract carryover
10 amount to cover expenditures.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:

- 12 1. It hereby approves and authorizes the modification in accordance
13 with the attached budget.
- 14 2. The Tohono O'odham Nation's Officials to wit: the Chairman and
15 Vice Chairman and any designated official are hereby authorized to
16 negotiate and execute the contract.

17 The foregoing Resolution was passed by the Tohono O'odham Council on the 02ND.
18 day of MARCH, 1999 at a meeting at which a quorum was present with a vote of 1,927.0
19 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers
20 vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono
21 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
22 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
23 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


