

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Tohono O'odham Department of Human Services - Division of Child**  
**Welfare Services - FY99 National Children's Alliance Grant)**

**RESOLUTION NO. 99-091**

1 WHEREAS, the Indian Protection and Family Violence Prevention Act of 1990, 25  
2 USC§§320 et seq., authorizes the use of multi-disciplinary teams to  
3 address the many issues in child abuse and neglect cases; and

4 WHEREAS, efforts have been made within the Tohono O'odham Nation to establish  
5 such a team; and

6 WHEREAS, each of the agencies participating on the team is committed to working  
7 cooperatively; and

8 WHEREAS, the National Children's Alliance has awarded the Division of Child  
9 Welfare Services \$35,000.00 to facilitate the formalization of the Multi-  
10 disciplinary Team.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council  
12 that:

- 13 1. The Tohono O'odham Legislative Council authorizes expenditures of  
14 these funds according to the attached budget.
- 15 2. That the Tohono O'odham Nation, to wit: the Chairman and any  
16 designated Official are hereby authorized to negotiate and execute  
17 the grant.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 02ND.  
19 day of MARCH, 1999 at a meeting at which a quorum was present with a vote of 1,927.0  
20 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers  
21 vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono  
22 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
23 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
24 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






