**(Approval of Community Based Diabetes Prevention Program FY 1998 Extended**  
**Budget Modification No. 1)**

**RESOLUTION NO. 99-093**

1 WHEREAS, the Tohono O'odham Nation Department of Human Services was  
2 approved for a grant to establish the Community Based Diabetes  
3 Prevention Program under the Special Diabetes Program for Indians,  
4 authorized by the Balanced Budget Act; and

5 WHEREAS, the Community Based Diabetes Prevention FY 1998 extended budget has  
6 been modified to establish new line items needed to support the  
7 operations of the program.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council  
9 hereby approves the Community Based Diabetes Prevention FY 1998  
10 extended budget Modification No. 1 in the amount of \$536,566.00 to  
11 establish new line items needed to support the operations of the program.

12 The foregoing Resolution was passed by the Tohono O'odham Council on the 02ND.  
13 day of MARCH, 1999 at a meeting at which a quorum was present with a vote of 1,927.0  
14 FOR; -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers  
15 vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono  
16 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
17 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
18 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






