RESOLUTION NO. 99-101

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Water Resources**
2 **Study Program under a P.L. 93-638 Contract with the Bureau of**
3 **Reclamation; and**

4 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono**
5 **O'odham Nation; and**

6 **WHEREAS, the Tohono O'odham Nation has submitted a proposed contract**
7 **application complete with a budget totaling \$1,514,831.00 to the Bureau**
8 **of Reclamation for the continuation of the Water Resources Study**
9 **Program during fiscal year 1998; and**

10 **WHEREAS, the United States has a statutory obligation pursuant to Section 303 (b) (1)**
11 **of the Southern Arizona Water Rights Settlement Act to provide funds for**
12 **the Water Resources Study Program; and**

13 **WHEREAS, the Water Resource Study Program does submit for review and approval**
14 **of Budget Justification reflecting the amount of \$1,514,831.00; and**

15 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 1999 Water**
16 **Resources Study Program contract proposal and budget.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**
18 **that:**

19 **1. The Tohono O'odham Legislative Council does authorize and request**
20 **the Bureau of Reclamation to renew with the Tohono O'odham**
21 **Nation under P.L. 93-638 as amended the provision of service titled:**
22 **Water Resources Study Program.**

23 **2. The duration of this contract will commence on October 1, 1998**

The foregoing Resolution was passed by the Tohono O'odham Council on the 02ND day of MARCH, 1999 at a meeting at which a quorum was present with a vote of 1,337.0 FOR; -0- AGAINST; 142.0 NOT VOTING; and 448.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
