12	WHEREAS,	on March 01, 1999, the Nation was notified by the Sells Service Unit that
13		a second surgery is needed to remove tumor wrapped around the major
14		artery in his body (see Dr. Lois Steele's letter dated March 1, 1999, to
15		Edward Manuel, Chairman of the Tohono O'odham Nation); and
16	WHEREAS,	the second surgery and radiation treatment is needed for Ricardo Garcia's
17		life so that he can have a bright and long future.
18	NOW, THER	EFORE, BE IT RESOLVED THAT the Executive Branch and Legislative
19		Branch review Ricardo Garcia's emergency medical hospital treatment
20		and approve:
21		1. The two surgeries performed by 1) University Medical Center
