(Adopting the Executive Branch's Initiative Administrative Budget Request  
for the Office of the Enrollment Program in the amount of \$74,709.84)**

**RESOLUTION NO. 99-107**

- 1   **WHEREAS, on June 28, 1997, Initiative IN-01-97, *O'odham Voice on Use of Gaming***  
2                   ***Revenues*, was enacted into law by the registered voters of the Tohono**  
3                   **O'odham Nation; and**
- 4   **WHEREAS, the Initiative authorized funding from Gaming Revenues for several**  
5                   **measures, including a one-time per capita distribution of \$2,000.00 to each**  
6                   **member of the Nation enrolled on June 28, 1997; and**
- 7   **WHEREAS, Enrollment Branch incurred expenses in complying with provisions of the**  
8                   **Initiative; and**
- 9   **WHEREAS, the Enrollment Office has advised the Executive Office of the Chairman**  
10                   **of the need for an additional appropriation to provide for the cost of**  
11                   **preparing the certification of eligible members in compliance with the**  
12                   **Revenue allocation plan; and**
- 13   **WHEREAS, the Enrollment Office did prepare and present a budget request, attached**  
14                   **and incorporated into this resolution; and**
- 15   **WHEREAS, the Executive Office of the Chairman recommends approval of this**  
16                   **budget request; and**
- 17   **WHEREAS, the Rules Committee and Budget & Finance Committee reviewed and**  
18                   **approved the attached budget; and**
- 19   **WHEREAS, the Legislative Council did by resolution #97-478, *Establishing Set-aside***  
20                   ***Accounts at Bank of America for Initiative Measures*, allocate \$1,800,000.00**  
21                   **to provide for the administrative cost of implementing the provisions of**  
22                   **Initiative IN-01-97.**

7 from the Initiative Administrative Costs set-aside account.


8 The foregoing Resolution was passed by the Tohono O'odham Council on the 03RD.

14 on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
