

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2000 Parenting Skills Training Program Contract Proposal**  
**- July 01, 1999 to June 30, 2003)**

**RESOLUTION NO. 99-108**

1 WHEREAS, the Tohono O'odham Department of Human Services has the primary  
2 responsibility to provide prevention and intervention services to families  
3 at risk for child abuse and neglect; and

4 WHEREAS, the Arizona Department of Economic Security provides funds for the  
5 development and administration of child abuse and neglect prevention  
6 programs under specified terms and conditions; and

7 WHEREAS, Parenting Training has been identified as one means of preventing child  
8 abuse and neglect; and

9 WHEREAS, the Tohono O'odham Department of Human Services has submitted a FY  
10 2000 proposal for Parenting Skills. The term of this contract shall be for  
11 four (4) years to commence on July 01, 1999 and end on June 30, 2003 and  
12 the first year budget, from 07/01/99 - 06/30/2000, is hereby submitted for  
13 review and approval.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council  
15 that the Tohono O'odham Nation's Officials to wit: the Chairman, Vice  
16 Chairman and any designated official are hereby authorized to negotiate  
17 and execute the contract.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 03RD.  
19 day of MARCH, 1999 at a meeting at which a quorum was present with a vote of 1,927.0  
20 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers  
21 vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono  
22 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
23 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
24 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
