6	VALENCIA is ½ degree or more of Papago-Tohono O'odham Indian						
7	blood, and has made a recommendation to the Tohono O'odham Council						
8	that the application be approved, all in accordance with the provisions of						
9	the Enrollment Ordinance; and						
10	WHEREAS, the Tohono O'odham Legislative Council has reviewed the						
11	recommendations of the Enrollment Committee and the evidence						
12	submitted in support of the individual applications.						
13	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council						
14	that the application for adoption filed by:						
15	MARIA ELENA GARCIA-VALENCIA 3131-ND-98						
16	is hereby approved and are hereby adopted into membership of the						
17	Tohono O'odham Nation.

24	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
