16 **Constitution of the Tohono O'odham Nation, and that their application is**
17 **approved, as herein above indicated.**

18 **BE IT FURTHER RESOLVED that the Chairman and other appropriate**
19 **officers of the Tohono O'odham Nation reduce this final determination in**
20 **writing regarding each of the foregoing applications for enrollment in**
21 **accordance with Section 1(a) of Article XIII of the Enrollment Ordinance;**
22 **give notice of this Council's determination in accordance with Section 2 of**
23 **Article XIII of the Enrollment Ordinance; and place the names of each**
24 **applicant upon the membership roll of the Tohono O'odham Nation in**
25 **accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.**

7 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
8 Act of June 18, 1934 (48 Stat. 984).




