**RESOLUTION NO. 99-129**

1 **WHEREAS, the Tohono O'odham Nation is known to have the highest rate of**  
2 **Diabetes Mellitus in the world; and**

3 **WHEREAS, due to the high rate of diabetes mellitus there is a high rate of limb**  
4 **amputations on the Tohono O'odham Nation; and**

5 **WHEREAS, the Tohono O'odham Legislative Council has a keen interest and concern**  
6 **in reducing limb amputation for members; and**

7 **WHEREAS, the Tohono O'odham Legislative Council has had the opportunity to meet**  
8 **Dr. Kham Vay Ung, D.P.M. and want Indian Health Service, Sells Service**  
9 **Unit to contract with Dr. Ung to provide second opinion prior to limb**  
10 **amputation as requested by patients; and**

11 **WHEREAS, the Tohono O'odham Nation through the Department of Human Services**  
12 **is working on a Scope of Work for education and prevention of limb**  
13 **amputation.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT THE LEGISLATIVE COUNCIL:**

- 15 **1. Requests to meet with Dr. Michael H. Trujillo, M.D. M.P.H.,**  
16 **Director Indian Health Service to assist the Tohono O'odham Nation**  
17 **with establishment of a contract with Dr. Kham Vay Ung through**  
18 **Sells Service Unit for second opinion(s) prior to any limb**  
19 **amputation(s) as requested by patients.**

20 **BE IT FURTHER RESOLVED that the Appropriations Committee are hereby authorized**

7 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
8 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
9 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
