

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 1999 Department of Human Services/Division of Community
Health Services - Elder Health Care Initiative Third Party Revenue Budget)**

RESOLUTION NO. 99-134

1 WHEREAS, the Tohono O'odham Nation is presently developing a Home Health
2 Agency under IHS Grant #ISH002103-02 with the Indian Health Services;
3 and

4 WHEREAS, the Legislative Council, through Resolution No. 98-501, established a new
5 Special Revenue Fund and budget for additional Personnel and
6 Operational expenditures in the amount of \$330,395.90; and

7 WHEREAS, a budget modification that proposes a change in the classes of staff to be
8 employed but not in the total dollar amount is submitted for review to
9 continue home health care to frail and disabled homebound elders.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
11 that it hereby approves the attached Elder Health Care Special Revenue
12 Fund Budget Modification #1 for FY 1999.

14 The foregoing Resolution was passed by the Tohono O'odham Council on the 17TH day
15 of MARCH, 1999 at a meeting at which a quorum was present with a vote of 1,595.0
16 FOR; -0- AGAINST; -0- NOT VOTING; and 332.0 [08] ABSENT, pursuant to the powers
17 vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono
18 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
19 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
20 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


