RESOLUTION NO. 99-135

1 WHEREAS, the Tohono O'odham Legislative Council appropriated \$80,000.00 to
2 sponsor the National Indian Gaming Association Convention Banquet;
3 and

4 WHEREAS, the Commerce Committee under estimated the actual cost of the brief
5 bags; and


6 WHEREAS, other additional costs have been added.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
8 appropriates additional funds in the amount of \$50,000.00 to cover
9 additional under estimated costs for the National Indian Gaming
10 Association Convention.

11 BE IT FURTHER RESOLVED that the funds be appropriated from the identified FY
12 1998 savings.

13 The foregoing Resolution was passed by the Tohono O'odham Council on the 17TH day
14 of MARCH, 1999 at a meeting at which a quorum was present with a vote of 1,004.5
15 FOR; 590.5 AGAINST; -0- NOT VOTING; and 332.0 [08] ABSENT, pursuant to the
16 powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the
17 Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986;
18 and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations)
19 on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
