8 order that their name(s) be deleted from the membership roll.


9 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on
10 the 05TH day of APRIL, 1999 at a meeting at which a quorum was present with a vote
11 of 1,341.0 FOR; 516.5 AGAINST; 69.5 NOT VOTING; and [02] ABSENT, pursuant to
12 the powers vested in the Council by Article II, Section 3 and Article IV, Section 1(h) of
13 the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
14 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
15 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
16 18, 1934 (48 Stat. 984).
