(Approving FY 99 Attorney Contract For David M. Juarez
to Serve as a Conflict Attorney)

RESOLUTION NO. 99-147

1 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's**
2 **Advocate Program is not ethically allowed to handle in the increasing**
3 **needs of tribal members for legal representation in civil and criminal**
4 **matters; and**

5 **WHEREAS, the Advocate Program wishes to retain David M. Juarez to be appointed**
6 **to represent clients with conflicts of interest who can not be represented**
7 **by the Nation's Advocate Program; and**

8 **WHEREAS, the Advocate Program wishes to retain David M. Juarez as Conflict**
9 **Attorney for the remainder of FY-99 and projects the cost of such services**
10 **at \$20,000.00; and**

11 **WHEREAS, the Advocate Program has presented a contract for David M. Juarez which**
12 **confirms and ratifies the terms and conditions related to future services,**
13 **a copy of which is attached; and**

14 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative**
15 **Council of an Attorney Contract with David M. Juarez on such terms for**
16 **the remainder of FY-99.**

17 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 18 **1. The Legislative Council ratifies and approves the Conflict Attorney**
19 **Contract for David M. Juarez in the form attached hereto, for the**
20 **remainder of FY - October 01, 1998 through September 30, 1999 in the**
21 **amount not to exceed \$20,000.00 total.**
- 22 **2. Funding for the Conflict Attorney Contract for David M. Juarez shall**
23 **be provided under the operating budget of the Advocate Program for**
24 **Fiscal Year 1999.**
