RESOLUTION NO. 99-149

1 WHEREAS, the Tohono O'odham Nation is presently operating the Community
2 Health Services Program under FY 1999 P.L. 93-638 Master Health
3 Contract No. 249-96-0001 with the Indian Health Services; and

4 WHEREAS, the Tohono O'odham Nations' Grants and Contracts Office has notified
5 the Community Health Services Division of Health Promotion/Disease
6 Prevention funds available in the amount of \$14,412.00; and

7 WHEREAS, a budget has been submitted for review and approval by the Department
8 of Health and Human Services, Division of Community Health Services
9 for the Health Promotion/Disease Prevention funds.

10 NOW, THEREFORE, BE IT RESOLVED THAT:

- 11 1. The Tohono O'odham Legislative Council hereby approves and
12 requests the Indian Health Services to modify the Master Health
13 contract No. 249-96-0001 to incorporate the attached budget.
- 14 2. The Tohono O'odham Nation's officials to wit: the Chairman and
15 Vice Chairman and any designated Official are hereby authorized to
16 negotiate, execute the contract and expend funds when received.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 06TH day
19 of APRIL, 1999 at a meeting at which a quorum was present with a vote of 1,927.0 FOR;
20 ~~0~~ AGAINST; ~~0~~ NOT VOTING; and [03] ABSENT, pursuant to the powers vested in
21 the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham
22 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
23 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
24 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
