8	WHEREAS,	there is a continued need for coordinated, comprehensive delivery of
9		basic Home Health Care to frail and disabled elders in their home on the
10		Tohono O'odham Nation; and
11	WHEREAS,	a budget modification is submitted for review to continue the
12		development of a Home Health Agency.
