1 **WHEREAS, the Tohono O'odham Nation has operated the Tuberculosis Control**
2 **Services Program to help prevent the spread of the disease through**
3 **community education, prevention, early detection, comprehensive**
4 **regimens and careful follow up with individuals; and**

5 **WHEREAS, funding for the operation of the Tohono O'odham Tuberculosis Control**
6 **Services Program has been provided in part through supplemental**
7 **funding sources; and**

8 **WHEREAS, the Division of Community Health Services - Tuberculosis Control**
9 **Services desires to continue the services it provides to TB susceptible**
10 **patients; and**

11 **WHEREAS, the Tohono O'odham Tuberculosis Control Services Program has received**
12 **funding from the State of Arizona, Department of Health Services for its**
13 **program.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 15 1. **The Tohono O'odham Legislative Council hereby approves the**
16 **proposal for funding of the Tohono O'odham Tuberculosis Control**
17 **Services Program from the State of Arizona Department of Health**
18 **Services and approves expenditures in accordance with the attached**
19 **budget.**
- 20 2. **The duration of this contract shall be from July 01, 1999 and remain**
21 **in effect as long as the Arizona Department of Health Services**
22 **agrees to fund the Tohono O'odham Tuberculosis Control Services**
23 **Program.**
