8		period (October 01, 1998 through March 31, 1999); in the amount of
9		\$117,120.78; and
10	WHEREAS,	there are sufficient funds for ALTCS revenues to cover salaries and fringe
11		for the next six (6) month period (April 01, 1999 - September 30, 1999) in
12		the amount of \$74,187.10.
13	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:
14		1. That it hereby approves extending FY 99 ALTCS budget from March
15		31, 1999 to September 30, 1999.
16		2. That it hereby approves budget modification #2 utilizing ALTCS
17		funds.
18		3. That the Tohono O'odham Nation's Officials to wit: the Chairman
19		and Vice Chairman and any designated official are hereby
20		authorized to negotiate and execute the grant, provided however,
21		that any amendment affecting the funding or funding levels of this
22		contract shall be submitted for further prior approval by this
23		Council.
