4		in part by Title III of the Older American's Act of 1965 as amended,
5		through the Administration of the Inter-Tribal Council of Arizona; and
6	WHEREAS,	the services provided to elderly members has been beneficial and services
7		continue to be necessary to provide nutritional and social support; and
8	WHEREAS,	the Elderly Program has prepared a proposal for FY 2000 Title III funding
9		to provide nutritional and social support services to eligible elderly
10		members.
11	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council,
12		1. That it hereby approves the proposal for Title III funding for the
13		Elderly Program to continue to provide such services it has proposed
14		per attachments in light of the requirements and regulations.
15		2. That the Nation has been informed by Inter Tribal Council on Aging
16		that the project period for this grant for FY 2000 will be from July 01,
17		1999 through June 30, 2000.
18		3. The Tohono O'odham Nation officials, to wit: the Chairman and
19		Vice Chairman or designated official are hereby authorized to
20		negotiate and execute the grant, provided however, that any
21		amendments affecting the funding or funding levels of this contract
22		shall be submitted for further prior approval by this Council.
