Expansion Third (3rd) year of a 3 year project to Health Resources and
Services Administration-HRSA)**

RESOLUTION NO. 99-158

1 WHEREAS, pursuant to resolution number 98-244, a Computer Network Expansion
2 three (3) year proposal was submitted and granted by the Health
3 Resources and Service Administration (HRSA); and

4 WHEREAS, the need to continue the development of preliminary planning for the
5 Establishment of a provider Network is still essential for improved
6 patient care and communications.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
8 Council:

- 9 1. Review and approves the third year budget and proposal of the three
10 year Grant for Network Expansion (Budget attached).
- 11 2. The Tohono O'odham Nation's Officials to wit: the Chairman and
12 any Designated official are hereby authorized to negotiate and
13 execute the grant and contract associated with the grant and expend
14 such funds when received.

15 The foregoing Resolution was passed by the Tohono O'odham Council on the 06TH day
16 of APRIL, 1999 at a meeting at which a quorum was present with a vote of 1,927.0 FOR;
17 -0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in
18 the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham
19 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
20 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
21 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


