

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Certifying the Appointment of Rose Johnson-Antone as Judge of the**  
**Tohono O'odham Courts)**

**RESOLUTION NO. 99-167**

1 WHEREAS, Section 4 of Article VIII of the Constitution of the Tohono O'odham  
2 Nation charges the Tohono O'odham Legislative Council the  
3 responsibility of appointing judges of the Tohono O'odham Courts; and

4 WHEREAS, a vacancy exists for a full-time judge's position; and

5 WHEREAS, the Judiciary Committee of the Legislative Council did forward the  
6 candidates applications to the Legislative Council for review; and

7 WHEREAS, the Tohono O'odham Legislative Council did interview the candidates  
8 and did review the candidate's qualifications and is prepared to make an  
9 appointment.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council  
11 that it hereby certifies the appointment of Rose Johnson-Antone as a full-  
12 time judge of the Tohono O'odham Courts to fill a six year term expiring  
13 on February 01, 2005.

14 The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH day  
15 of APRIL, 1999 at a meeting at which a quorum was present with a vote of 1,200.0 FOR;  
16 727.0 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested  
17 in the Council by Section 4 of Article VIII of the Constitution of the Tohono O'Odham  
18 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by  
19 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
20 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
