

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Certifying the Appointment of Patricia "Pogo" Overmeyer to Unexpired  
Term of Judge's Position)**

**RESOLUTION NO. 99-171**

1 WHEREAS, the Tohono O'odham Legislative Council did appoint Rosalie Lopez as  
2 Judge of the Tohono O'odham Courts for a six (6) year term ending  
3 February 1, 2003; and

4 WHEREAS, Ms. Lopez has resigned her position as a Judge of the Tohono O'odham  
5 Courts; and

6 WHEREAS, by Resolution No. 99-171, the Tohono O'odham Legislative Council did  
7 appoint Patricia "Pogo" Overmeyer as a full-time Judge of the Tohono  
8 O'odham Courts; and

9 WHEREAS, the Tohono O'odham Legislative Council would like to specify that Ms.  
10 Overmeyers' initial term fulfill the unexpired term vacated by former  
11 Judge Lopez.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council  
13 that it hereby certifies the appointment of Patricia "Pogo" Overmeyer as  
14 a full-time Judge of the Tohono O'odham Courts to fill the unexpired  
15 term vacated by former Judge Lopez, ending on February 1, 2003.

16 The foregoing Resolution was passed by the Tohono O'odham Council on the 07TH day  
17 of APRIL, 1999 at a meeting at which a quorum was present with a vote of 1,143.5 FOR;  
18 783.5 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested  
19 in the Council by Section 4 of Article VIII of the Constitution of the Tohono O'Odham  
20 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by  
21 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
22 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




