10	WHEREAS,	as a result of the voting two (2) applicants were approved for six year			
11		terms and two (2) applicants were approved to fill the one (1) unexpired			
12		term of Judge Rosalie Lopez; and			
13	WHEREAS,	the Tohono O'odham Legislative Council members were further			
14		canvassed to determine which of the two applicants approved would fill			
15	·	the vacancy to the unexpired term.			
16	NOW, THER	EFORE, BE IT RESOLVED that the Legislative Council hereby rescinds			
17		Resolution No. 99-170, "Certifying the Appointment of Yolanda Strickland			
18		to Unexpired Term of Judge's Position."
