

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adoption of the Executive Branch Supplement Budget for Fiscal Year 1999)**

**RESOLUTION NO. 99-175**

1 WHEREAS, the Executive Branch has prepared and presented the Executive Branch  
2 Supplement Budget for fiscal year 1999 in the amount of \$3,500,000; and

3 WHEREAS, the Executive Branch requests that the supplemental funding listed as  
4 recurring operational expense be made a part of the operating base for the  
5 programs identified.

6 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council  
7 that the Executive Branch Supplement Budget for fiscal year 1999, in the  
8 amount of \$3,500,000, is hereby adopted as presented and is authorized  
9 to be expended accordingly.

10 BE IT FURTHER RESOLVED, that the budget as appropriated is further authorized to  
11 become a part of the base funding for each respective program.

13 The foregoing Resolution was passed by the Tohono O'odham Council on the 08TH day  
14 of APRIL, 1999 at a meeting at which a quorum was present with a vote of 1,737.0 FOR;  
15 -0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in  
16 the Council by Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono  
17 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
18 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
19 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
