

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Department of Human Services/Division of Child
Welfare/Children's Home Program Budget Modification #3)**

RESOLUTION NO. 99-190

1 WHEREAS, the Tohono O'Odham Department of Human Services is presently
2 operating the Department of Human Services/Division of Child Welfare
3 Services under a Master Contract with the Secretary of Interior; and

4 WHEREAS, the budget modification is necessary to address renovation costs of the
5 Children's Home and Developmentally Disabled Home; and

6 WHEREAS, a budget modification has been submitted which does not change the
7 funding level, but includes new line items and modifies other line item
8 amounts to address current needs.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
10 that:

- 11 1. It hereby authorizes the expenditures of these funds according to the
12 attached budget.
- 13 2. The Tohono O'odham Nation's Official to wit; the Chairman and Vice
14 Chairman and any designated official are hereby authorized to
15 negotiate and execute the contract.

17 The foregoing Resolution was passed by the Tohono O'odham Council on the 19TH day
18 of APRIL, 1999 at a meeting at which a quorum was present with a vote of 1,785.0 FOR;
19 -0- AGAINST; -0- NOT VOTING; and 142.0 [05] ABSENT, pursuant to the powers
20 vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono
21 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
22 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
23 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


