RESOLUTION NO. 99-193

1 **WHEREAS, the Tohono O'odham Nation did on Saturday, April 24, 1999 conduct a**
2 **Primary Election for the offices of Chairman and Vice Chairman of the**
3 **Tohono O'odham Nation as well as Chairman and Vice Chairman to the**
4 **Tohono O'odham Districts; and**

5 **WHEREAS, the Election Board did issue and post its Certification of Election Results**
6 **in accordance with Section 6 (E) of Article VII of the Uniform Election**
7 **Ordinance, certifying the election of the candidates who received the**
8 **highest number of votes for elective offices; and**

9 **WHEREAS, pursuant to Section 5 (E) of Article V and Section 2 (F) (5) of Article VI of**
10 **the Uniform Election Ordinance, it is incumbent upon the Election Board**
11 **to certify to the Council these election results provided, that no election**
12 **contest statement has been filed against the candidates within the time**
13 **allowed; and**

14 **WHEREAS, no contests have been filed within the time period allowed.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative**


