

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override of Vetoed Resolution No. 99-174, "Rescinding Resolution No.
99-170, "Certifying the Appointment of Yolanda Strickland to Unexpired
Term of Judge's Position")**

RESOLUTION NO. 99-197

1 WHEREAS, during the April 07, 1999 General Session of the Tohono O'odham
2 Legislative Council, the Legislative Council did pass Resolution No. 99-
3 174; and

4 WHEREAS, upon presentation of Resolution 99-174 to the Chairman of the Tohono
5 O'odham Nation, he did disapprove thereof and returned it to the Council
6 with his objections in accordance with the provisions of Article VII,
7 Section 5 of the Constitution of the Tohono O'odham Nation; and


8 WHEREAS, during the May 03, 1999 Legislative Session, the Chairman of the Nation
9 presented his justifications in vetoing Resolution 99-174 (a copy of which
10 is attached hereto); and

11 WHEREAS, the Tohono O'odham Legislative Council has reviewed the Chairman's
12 objections and after consideration, again voted to pass Resolution No. 99-
13 174.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
15 Council does hereby override the Chairman's veto by a majority of two-
16 thirds of the votes cast.

17 The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on
18 the 03RD. day of MAY, 1999 at a meeting at which a quorum was present and by a vote
19 of 1,307.5 FOR; 619.5 AGAINST; -0- NOT VOTING; and [03] ABSENT, was passed by a
20 majority of two-thirds (2/3) [1,284.6] of the votes cast as required by Section 5 of Article
21 VII of the Constitution of the Tohono O'odham Nation.


