

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Certifying the Appointment of Teresa Donahue as Judge of the**  
**Tohono O'odham Courts)**

**RESOLUTION NO. 99-198**

1 WHEREAS, Section 4 of Article VIII of the Constitution of the Tohono O'odham  
2 Nation charges the Tohono O'odham Legislative Council the  
3 responsibility of appointing judges of the Tohono O'odham Courts; and

4 WHEREAS, a vacancy exists for a full-time judge's position; and

5 WHEREAS, the Judiciary Committee of the Legislative Council did forward the  
6 candidates applications to the Legislative Council for review; and

7 WHEREAS, the Tohono O'odham Legislative Council did interview the candidates  
8 and did review the candidate's qualifications and is prepared to make an  
9 appointment.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council  
11 that it hereby certifies the appointment of Teresa Donahue as a full-time  
12 judge of the Tohono O'odham Courts to fill a six year term expiring on  
13 February 01, 2005.

14 The foregoing Resolution was passed by the Tohono O'odham Council on the 03RD.  
15 day of MAY, 1999 at a meeting at which a quorum was present with a vote of 1402.5  
16 FOR; 524.5 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers  
17 vested in the Council by Section 4 of Article VIII of the Constitution of the Tohono  
18 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
19 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
20 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


