1 Article XIII of the Enrollment Ordinance; and place the names of each  
2 applicant upon the membership roll of the Tohono O'odham Nation in  
3 accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.

4 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on  
5 the 03RD day of MAY, 1999 at a meeting at which a quorum was present with a vote  
6 of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the  
7 powers vested in the Council by Section 1 of Article II and Section 1(h) of Article VI of  
8 the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
9 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
10 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
11 18, 1934 (48 Stat. 984).


