

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Budget Amendment No. 2 of the Pisinemo District to Utilize \$20,000.00 from
the Pisinemo District's Savings to Purchase a Van for the Pisinemo District)**

RESOLUTION NO. 99-208

1 WHEREAS, at a regularly scheduled session of the Legislative Council, the Pisinemo
2 District did present before the Tohono O'odham Legislative Council a
3 budget amendment to authorize the utilization of \$20,000.00 from the
4 District's savings to purchase a new van for the District; and

5 WHEREAS, the Pisinemo District decided to purchase a new van to replace the
6 District's 1994 Dodge Van now in use, which due to excessive mileage has
7 caused increased breakdowns and service costs; and

8 WHEREAS, the Pisinemo District does have sufficient funds available in the District's
9 Gaming revenue disbursement savings to add \$20,000.00 to its capital
10 equipment line item to make this purchase; and

11 WHEREAS, the Pisinemo District did approve to transfer \$20,000.00 from its savings
12 account 010100000540221 to checking account 25271537 for the vehicle
13 purchase.

14 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does support the
15 budget amendment of the Pisinemo District to utilize \$20,000.00 from the
16 Pisinemo District's savings to accomplish the purchase of a van.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 05TH day
19 of MAY, 1999 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; 0
20 AGAINST; 0 NOT VOTING; and 0 ABSENT, pursuant to the powers vested in the
21 Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham
22 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
23 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
24 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
