

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Tohono O'odham Nation to Maintain the Early Childhood Facilities**  
**at Pisinemo, Santa Rosa and Vaya Chin under the Facilities**  
**Maintenance Department**

**RESOLUTION NO. 99-219**

1 WHEREAS, Pisinemo, Santa Rosa and Vaya Chin communities have requested  
2 through their respective Districts community facilities/buildings under  
3 ICDBG 1999; and

4 WHEREAS, the Tohono O'odham Nation has the technical expertise and resources  
5 required to provide and adequately maintain these buildings; and

6 WHEREAS, it is in the best interests of the Hickiwan, Gu Achi and Pisinemo Districts  
7 and the Tohono O'odham Nation that maintenance be provided by the  
8 Tohono O'odham Nation.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council  
10 hereby grants that these systems be turned over to the Nation to provide  
11 ongoing maintenance, once the projects are completed and operational.

12 The foregoing Resolution was passed by the Tohono O'odham Council on the 06TH day  
13 of MAY, 1999 at a meeting at which a quorum was present with a vote of 1,738.0 FOR;  
14 -0- AGAINST; -0- NOT VOTING; and 189.0 [08] ABSENT, pursuant to the powers  
15 vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono  
16 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
17 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
18 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
