(Certifying Tohono O'odham Nation's Commitment to Contribution of
Leverage for the Cost of Demolition and to Supplement Contingency
for Recipients under 1999 ICDBG)**

RESOLUTION NO. 99-220

1 **WHEREAS, the following communities and districts have requested funding of the**
2 **specified Projects:**

3 **Early Childhood Centers at Santa Rosa, Vaya Chin and Pisinemo**
4 **communities; and**

5 **WHEREAS, the above listed communities and the recipients in those communities**
6 **seek to receive community facilities/buildings to be funded under HUD-**
7 **ICDBG for 1999; and**

8 **WHEREAS, the ICDBG program allows for a mix of funds from different sources to**
9 **bring to the project; and**

10 **WHEREAS, the Tohono O'odham Nation commits to funding portions of the costs for**
11 **demolition and supplement the contingency fund, which is a total of**
12 **\$375,000.00.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation does certify**
14 **and commit \$375,000.00 to the cost of demolition and to supplement**
15 **contingency under the 1999 ICDBG program, contingent upon receiving**
16 **the grant award from HUD-ICDBG.**

18 **The foregoing Resolution was passed by the Tohono O'odham Council on the 06TH day**
19 **of MAY, 1999 at a meeting at which a quorum was present with a vote of 1,738.0 FOR;**
20 **-0- AGAINST; -0- NOT VOTING; and 189.0 [08] ABSENT, pursuant to the powers**
21 **vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono**
22 **O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and**
23 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on**
24 **March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


