

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Building Codes For Funding by HUD For ICDBG 1999 Proposed Projects)**

RESOLUTION NO. 99-223

1 WHEREAS, the Department of Housing and Urban Development guidelines require
2 adoption of standards on projects funded through the Department's
3 ICDBG Programs; and

4 WHEREAS, the Tohono O'odham Nation is applying for funds for the 1999 ICDBG
5 Program to be used to construct community facilities within the Tohono
6 O'odham Nation; and

7 WHEREAS, the Nation recognizes the need and desirability for such standards and
8 building codes to ensure construction quality for all members of the
9 Nation.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council
11 that all projects funded in the 1999 cycle of the HUD-ICDBG Program for
12 community facilities/buildings will conform to all applicable building
13 codes and standards including the Administration for Children and
14 Families building and space requirements for Early Childhood Head Start
15 centers, the Uniform Building Code as amended and adopted in Pima
16 County, Arizona and shall meet or exceed nationally accepted minimum
17 standards for these kinds of facilities.

19 The foregoing Resolution was passed by the Tohono O'odham Council on the 06TH day
20 of MAY, 1999 at a meeting at which a quorum was present with a vote of 1,738.0 FOR;
21 -0- AGAINST; -0- NOT VOTING; and 189.0 [08] ABSENT, pursuant to the powers
22 vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono
23 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
24 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
25 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
