

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Tohono O'odham Department of Human Services Network
Expansion Program Budget, Modification Number One for FY 99, the
second year of a 3 year project to Health Resources and Services
Administration - HRSA)**

RESOLUTION NO. 99-226

1 WHEREAS, pursuant to Resolution Number 98-244, a Computer Network Expansion
2 three (3) year proposal was submitted and granted by the Health Resources
3 and Service Administration (HRSA); and

4 WHEREAS, a budget modification is submitted for review and approval by the
5 Department of Human of Services to utilize federal carry-over funds of
6 \$143,169.14 from the FY-98 budget and to reflect the authorized grant
7 amount of \$139,755.00; and

8 WHEREAS, the unused federal funds will be dispersed into newly added line items
9 and existing line items are to be deleted with their balances being
10 incorporated into the newly added line items for FY-99 budget.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:

12 1. It hereby approves and authorizes expenditures in accordance with
13 the attached budget modification #1 submitted by the Department of
14 Human Services.

15 2. The Tohono O'odham Nation officials, to wit: the Chairman and Vice-
16 Chairman and any designated official are hereby authorized to
17 negotiate and execute the contract.

18 The foregoing Resolution was passed by the Tohono O'odham Council on the 06TH day
19 of MAY, 1999 at a meeting at which a quorum was present with a vote of 1,738.0 FOR; -0-
20 AGAINST; -0- NOT VOTING; and 189.0 [07] ABSENT, pursuant to the powers vested in
21 the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham
22 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
23 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
24 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
