1   **WHEREAS, the Department of Health & Human Services has for some time had the**  
2                   **desire to bill for services provided from Medicaid (Arizona Health Care**  
3                   **Cost Containment System) and Medicare (Arizona Long Term Care) and**  
4                   **other(s); and**

5   **WHEREAS, the Department's Divisions Managers have applied for provider**  
6                   **identification numbers from the AHCCCS Office of the Arizona**  
7                   **Department of Health Services; and**

8   **WHEREAS, the Department's Division Managers have agreed to establish one Special**  
9                   **Revenue Fund account for all services eligible for billing and**  
10                  **reimbursement with the exception of the Home Health Agency Project and**  
11                  **Arizona Long Term Care Services (ALTCS) which already have an account.**

12   **NOW, THEREFORE, BE IT RESOLVED that the Executive and Legislative Branches**  
13                  **have reviewed and approve:**

- 14                  1.   **Establishment of a second Special Revenue Fund for the Department**  
15                           **of Health and Human Services Division(s) billing and collection from**  
16                           **AHCCCS and other funds generated through Third Party Billing.**
- 17                  2.   **An annual budget(s) will be developed based on the Special Revenue**  
18                           **Fund account projections and budgets(s) will be modified as**  
19                           **necessary so that the special revenue fund is not over expended.**
- 20                  3.   **In any given fiscal year, unspent Department of Health and Human**  
21                           **Services Third Party Billing revenue will be available for re-**  
22                           **appropriation in the future fiscal years.**
